#### Who am I?

- Registered Learning Disability Nurse since 1998
- Worked across a range of NHS services in Kent, working in the community since 2009.
- Developed an accidental interest in End of Life care
- Co-Chair of the Kent branch of the PCPLD network
- Developed local pilot ACC project in a small number of residential services
- HEE KSS Bid for funding successful for running a 12 month project to implement the ACC in South Kent Coast CCG.





#### What is the Anticipatory Care Calendar?

- The ACC is a free resource for any social care setting supporting individuals with learning disabilities or dementia.
- This simple tool aims to improve health surveillance for adults with Learning Disabilities.
- A "traffic light system" triggers a specified response to changes in health presentation across 12 domains.
- The ACC was designed following the tragic and potentially preventable death of Robert; a young man with Down's syndrome and Testicular cancer.





#### What is the Anticipatory Care Calendar?

- The tool was designed in the North of England, and has been widely implemented there through a strategic health authority grant.
- With Free on line training, and local support the monthly by month Calendar can be used to review trends in health changes.
- This in turn can be used to cluster information; and to provide evidence to other health professionals







#### **The Anticipatory Care Calendar**

The Calendar works on a "traffic light" system

Green – Normal for that person no action required

Yellow – Requires response (detailed on calendar)

Red – Requires response and manager follow up

#### Why use an Anticipatory Care Calendar?

- Unqualified carers may lack confidence in responding to health changes.
- Use of bank staff, part time staff, and lone working may mean health changes are lost or not followed up.
- For example Pain relief is often only given once a day;
   the calendar prompts to follow this up.
- A calendar allows clear tracking of changes, with identified actions in response to those changes.





## **Current and Future Developments with the ACC**

- The "home" of the ACC has recently moved from Cheshire and Merseyside Cancer Care Network to the Patient Safety arm of the North West Academic Health Sciences Network.
- The E-Learning platform is changing and is in the process of being redeveloped to enable easier, free access to the training module.
- Pre and Post implementation Metrics being identified to provide clinical audit trail demonstrating benefits of ACC
- Digital Version being planned with ability to spread ACC further and with automated data collection





#### South Kent Coastal ACC Pilot Project

- HEE KSS have funded a 12 month localised pilot to introduce, and run the ACC in South Kent Coast CCG
- Locality has high density of providers and homes for people with Learning Disabilities
- Official project start 13<sup>th</sup> June 2016 !!





#### South Kent Coast ACC Pilot

#### Plan:

- Seek and approach interested providers
- Design "pre" metrics with NWAHSN and key provider who has indicated interest in ACC across their services.
- E-Learning platform and access to paperwork being re designed during this time of data gathering.
- Support interested providers to complete e-learning
- Support providers to implement ACC including baseline assessments and bespoke training where required.
- Design audit tool to ensure ACC is implemented correctly.





#### **Thoughts and Questions**

Could the ACC provide a platform to support Transition for young people into Adult services – making use of the invaluable knowledge of parents to provide the baseline, and help to smooth a move away from the family home?
