##### **Professor the Baroness Finlay of Llandaff**



Hon. Professor of Palliative Medicine, Cardiff University; first Palliative Medicine consultant in Wales (1987). **Chairs the National Mental Capacity Forum on behalf of the Ministry of Justice and Department of Health**; Chairs the National Council for Palliative Care. Welsh Woman of the Year 1996 – 97; 2008 'Woman Peer of the Year'; and 2007 Parliamentary Charity Champion.

Chaired Royal College of General Practitioners Commission on Medical Generalism. House of Lords: Crossbench Peer since 2001.

Currently taking the Access to Palliative Care Bill through Parliament.

##### **Professor Glynis Murphy**

Professor Glynis Murphy is a chartered clinical and forensic psychologist, HCPC member and Fellow of the British Psychological Society. She currently works at The Tizard Centre, University of Kent. **For many years she has had research interests in challenging behaviour, autism, sexuality, abuse, forensic issues, mental capacity and the law in intellectual disabilities and she has published over 130 journal articles, book chapters and books on these topics.** She recently chaired the UK government's NICE guidelines development group for Challenging Behaviour and Learning Disabilities.
