

Community of Practice Event Evaluation

Three sources of information were gathered at the Community event on 1st December 2023:-

- 1) Participants attendance data
- 2) Pitch Feedback
- 3) Baubles feedback

Anonymised or deidentified data is collected in the appendix, while below is some analysis undertaken by steering group members and reviewed by the wider Steering group at a meeting on 19th December 2023.

Attendance

In comparing the list of attendees made on the day with the Eventbrite register, the most noticeable issue is that the former (68 names -some people were missed) is longer than the latter (63 names) This is due at least partly to most steering group members and most presenters not feeling the need to get a ticket. There are also many instances of names appearing on one list only, though to what role (participant or "supporting" presenter) they belong is unclear. A copy of the Eventbrite attendance list will aid analysis at future events.

Pitch feedback

A group of the Steering group utilised content analysis to make sense of the data shared by participants at the event, this can be found in Appendix 1.

This information was themed into activities that can be undertaken by:-

- 1) individual members of the community,
- 2) through working with others in the Community of Practice
- 3) sharing practice through the Community of Practice
- 4) advocating for change

Two significant themes for consideration:-

- Representation and engagement of experts by experience in the Community's Steering group activity.
- Support better understanding of Learning Disability Nursing workforce issues in the Kent Surrey Sussex area.

Baubles interpretation

Data in Appendix 2

44 delegates provided feedback on a bauble

41/44 baubles contained broad praise, thanks and positivity 😊 😇

14/44 baubles specifically referred to the inclusivity and accessibility of the conference



4/44 baubles singled out the choir

2/44 baubles singled out the value of including people with PMLD

2/44 baubles reminded us to avoid jargon

7/44 baubles gave recommendations for the future which included running the conference each year, extending the invitation to LD students, spreading the word to capture more professionals, using easy read, and more involvement from community services such as carers/support workers.

Actions

- 1) Have a copy of the attendance list at future face-to-face events
- 2) Reconfigure the Steering group to ensure representation from experts by experience from across Kent Surrey and Sussex.
- 3) Share opportunities such as Funeral Planning work with the Community via the website.
- 4) Support and facilitate through hosting a regional piece of work on the Learning Disabilities Nursing workforce.
- 5) Share pitch data with presenters.
- 6) Share evaluation on CoP website
- 7) Undertake annual Conferences.
